What are OERs?



FREELY AVAILABLE

Most are legal to copy, adapt, and redistribute semester after semester.



OPEN

"Open" means openly licensed, indicating they are in the public domain or the copyright holder has abridged rights to eliminate barriers to access/use/derivative works.



CC LICENSED

Often contain a Creative Commons license. Check each resource for use rights.

Open Educational Resources (OERs): The Basics

What are Open Educational Resources?

Open Educational Resources (OERs) are teaching and learning materials that you may freely use and reuse, without charge. That means they have been authored or created by an individual or organization that chooses to retain few, if any, ownership rights. For some of these resources, that means you can download the resource and share it with colleagues and students. For others, it may be that you can download a resource, edit it in some way, and then re-post it as a remixed work. OERs often have a Creative Commons license that states specifically how the material may be used, reused, adapted, and shared.

What are the potential benefits of both using and creating OERs?

- Improving student performance and satisfaction
- Increasing access to educational materials for a wider range of learners,
 predominantly those underserved by traditional educational opportunities
- Creating community around critical reflection on and discussion of educational resources
- Helping students and institutions save money

What are some examples of OERs?

- Modules or other learning activities that provide insight and analysis on a particular subject, problem, question, or concept
- Lesson plans and syllabi
- Complete peer-reviewed electronic textbooks that replace traditional texts
- Full university courses, which might include course readings, media, lectures, assignments, problem sets, sample work, and even lecture notes
- Software and tools that support the creation, delivery, use, and improvement of open learning content, including searching and organization of content, content and learning management systems, content development tools, and online learning communities
